# 2. HIGHLIGHTS

The year 2022 started with optimism after two consecutive years of unprecedented global change and disruption. As the restrictions of the COVID-19 pandemic receded, a renewed appetite and enthusiasm for greater connection, comprehensive knowledge sharing and in-person meetings and events emerged.

This in turn impacted the Platform itself. In order to address these challenges, the Geneva Peacebuilding Platform made core changes in the first half of 2022.

Dr. Annyssa Bellal formally joined the Platform as Executive Coordinator, now Executive Director, from January 2022. After three successful years steering the Geneva Peace Week through multiple transitions and a pandemic, Danson Gichini concluded his role as Geneva Peace Week Lead. He was replaced by Dany Diogo, incoming Project Lead for Geneva Peace Week. In order to assist the core team for the successful delivery of the 2022 edition of the Geneva Peace Week, two additional part-time roles were fulfilled by Maria Baltag, in charge of all Administrative and Financial aspects and Yasmeen Chaudhry in the capacity of Communications and Outreach Coordinator, starting from the later part of July 2022. Annika Erickson-Pearson, Community Management Lead, remained with the platform throughout the year.

Thus, with a brand new team, the Geneva Peacebuilding Platform embarked on yet another steep transition period over five short months. The newly formed team has since continued to take the necessary time to reflect on the strategic positioning of GPP in the rapidly changing landscape of peacebuilding, especially in light of the Security Council Seat and Presidency by Switzerland in the coming two years, for the period of 2023-2024.

For the Platform, the usual annual activities and in-person meetings took the possible re-emergence of COVID-19 into account, with an emphasis on a return to in-person convenings wherever possible. It was a successful year:

#### Geneva Peace Week 2022

After two editions that were held almost fully online due to the global pandemic, considerable efforts were made to offer as many traditional in person events as possible, with an emphasis on daily High-Level panels, while keeping some sessions online to retain the reach and expansion that was successfully achieved in prior editions.

Geneva Peace Week 2022 consisted of **34** workshops (**16** in-person and **18** online sessions), **9** High-Level panels, **21** Digital Series productions generating over **1900** streams and listens as of **11** January 2023. Overall, the week engaged **2,860** people from **119** countries.

#### Geneva Dialogue on Environment, Climate, Conflict, and Peace

This year, the Geneva Peacebuilding Platform invested considerable energy into its most robust community of practice: **the Geneva Dialogue on Environment, Climate**, **Conflict and Peace (ECCP)**. The community published a *White Paper on the Future of Environmental Peacebuilding*, a joint product of 300 individuals from around the world, brought that White Paper to Stockholm+50, and started a track on exchanging expertise between practitioners at the local level.

#### **Community Convening**

With the outbreak of war on the European continent at the beginning of the year 2022, the Platform co-hosted breakfast discussions on the war in Ukraine in collaboration with the Geneva Graduate Institute and Geneva experts. In addition, GPP continued to advance networking between professionals and academics working on peace and security dynamics in China (Beijing-Geneva Digital Briefings on Sustaining Peace and Preventive Diplomacy), and it facilitated informal exchanges between peace forum organizers to nurture exchange and collaboration between them (Peace Forum Network). The Platform hosted various thematic talks and book launches detailed below.

# **3. CONVENING & INCUBATION**

The Geneva Peacebuilding Platform, since its founding in 2008, has provided a space for the incubation of new ideas and practices for peacebuilding. This section reports on Pillar 1 of the GPP's 2022 programme which focuses on facilitating continuous exchange surrounding innovative practices and thinking on peacebuilding.

## 3. Annual Retreat of the Geneva Peacebuilding Platform

The Geneva Peacebuilding Platform's 2022 Annual Retreat of the Advisory Board took place on 28th June 2022, in-person, on the premises of Interpeace and convened eighteen board members from a range of Geneva institutions to exchange and explore priorities for peace in 2022. The two objectives of the retreat were to identify and exchange on critical or urgent priorities for peace in 2022, and to reflect on the role of Geneva, broadly, and the Advisory Board, specifically, in advancing those priorities.

As part of its growing commitment to investing in facilitation and new techniques, the Geneva Peacebuilding Platform team designed a highly interactive structure that maximized both participation and output. Participants connected in small groups, in pairs, and to the larger full group at different moments, with careful direction and tools provided by the Facilitator.

#### Priorities for peace in 2022

Participants were invited to start the retreat in small conversations to identify priorities or areas of critical focus for peace in 2022 and beyond. Through an exercise "3-2-1," participants were placed in groups of 3, invited to identify 2 things that they all had in common with regard to the peacebuilding work in Geneva, and then to find 1 common priority or urgent issue that they are working, or will work, to address.

Four thematic priorities emerged from the conversation:

#### Peace infrastructure, multilateralism, and inclusion

Much of the discussion among participants across the Geneva peace community was highly self-reflective:

- Is a multilateral approach to peace possible, particularly in response to multiple geopolitical crises?
- What future for Geneva and the multilateral institutions present?
- How might we evaluate and ensure that the answers produced in Geneva actually fit the questions and problems they purport to address?
- What infrastructure is required to build and secure peace across power transitions?
- What have we learned in the past five years about practicing inclusion, and how might we improve?
- What role for agency?

#### Climate change, just transitions, and peace

Discussion on environment, climate change, conflict, and peace has expanded exponentially in Geneva over the past two years. Participants discussed the need to capitalize and build on this momentum, capturing priorities and recommendations in policy on both bilateral and multilateral levels. Climate change adaptation and energy transitions will impact communities around the world, and the peacebuilding field must do more to understand this moving target.

- What does the "energy transition" or a "just transition" mean for social contracts in conflict-affected communities?
- How might we widen a justice lens beyond accountability to strengthen social cohesion?

#### Technology and non-state actors

The possibilities of leveraging technology for peacebuilding piqued the interest of Advisory Board members, who saw digital transformation as an opening for private or business actors to join peace and development conversations. Both private actors and digital technology were seen as both an enabler of and a challenge for peace.

- What role might business actors play in building peace?
- How is technology impacting social fabric, and what role might international Geneva play in the field, particularly when the impacts are viewed more as social issues than "peace issues"?

#### Prevention

Prevention approaches enable different lenses:

- Particularly in light of the invasion of Ukraine, what gaps are present and how might they be filled?
- How might regional organizations better advance conflict prevention priorities?

Much of the conversation revolved around the multidimensionality of crises today (armed conflict, the COVID19 pandemic, socioeconomic crisis, etc.) and how enabling better mechanisms of prevention might allow for forward progress in a stalled landscape.

Beyond these priorities, the group also discussed gaps in the current landscape. Human mobility is following increasingly varied patterns which must be examined in order to understand potentially disruptive impacts. The group discussed "Peacebuilding," revisiting multi-track diplomacy, politics, and a revival of statecraft in the face of erosion of norms and multilateralism. Geopolitical shifts are also impacting the function and operation of regional organizations, which seem to be reaching beyond their capacity; how can we understand the evolving role and strengths of regional bodies?

## 3.2 Geneva Peace Talks Initiative

The 10th edition of the PeaceTalks took place on 21 September 2022, on the International Day of Peace at the Palais des Nations in Geneva. The event welcomed an in-person audience and was live streamed online, as a hybrid event. The Geneva Peacebuilding Platform contributes to the PeaceTalks each year with financial as well as in-kind support in the form of time from the Executive Director and Community Management Lead towards thematic development and overall coordination. This year, the Platform hired and coordinated a team of temporary student staff who provided logistical support on the 20th and 21st of September.

"What does peace mean to you?", the theme from the first ever Geneva PeaceTalks held in 2013, was revisited by the speakers as 2022 to mark the 10th edition of this event. In parallel, the official United Nations' theme for the International Day of Peace, "End racism. Build peace" also underpinned the event.

Racism and all forms of discrimination prevent the building of societies where all members can flourish. Entrenched hierarchies between humans, and between nature and humans, continue to cause undue harm to all living creatures on our planet. The dismantling of discriminatory structures is key to support equality and human rights everywhere.

Coming from different backgrounds and contributing different perspectives, each speaker shared their tangible experiences and ideas to inspire people to reflect on the meaning of peace and sparked a discussion on how each and every one of us can contribute to creating a world that we can truly be proud of.

## 3.3 Opening Event of Geneva Peace Week

The Opening Day of the Geneva Peace Week 2022 was dedicated to in-person High-Level panels with prominent actors of the peacebuilding communities sharing insights and best practices to mark the return of in-person events.

Organized by the GPP in partnership with the GCSP and Principles for Peace, the Opening Day was comprised of five panels welcoming a prestigious array of guests to discuss the overarching theme of "**Peace is possible**". Throughout the day, the total number of attendees reached <u>664 participants</u>.

The Opening Day started with Welcome Addresses delivered by:

The welcome addresses were followed by a High-Level panel on "Peace is possible: A view from policy leaders" delivered by the members of the Platform's Steering Committee that comprises each of the heads of GPP's partners:

The panel was attended by 110 participants.

This panel was followed with storytelling from young peacebuilders that shared their experiences through the lens of GPW22 four thematic tracks:

- Digital peace,
- Environmental challenges,
- Moving beyond securitization, and
- Rights and inequalities.

This event was attended by 77 participants.

Following a lunch break provided by the GPW22, the Opening Day resumed with a High-Level panel organized by the Geneva Center for Security Policy (GCSP) entitled: "Making peace possible - What's "new"on the New Agenda for Peace?", with speakers:

The High-Level panel was followed by a special event organized by the Principles for Peace initiative which was a global participatory initiative to develop a new set of principles, standards and norms that will fundamentally reshape how peace processes are structured, sequenced and actualized. This panel was attended by <u>112 participants</u>.

The esteemed panelists were joined by two prominent speakers, namely, **Amb. Anna Jardfelt**, Permanent Representative of Sweden to the International Organisations in Geneva, and **Amb. Hans-Peter Jugel**, Deputy Permanent Representative of Germany to the International Organisations in Geneva.

The Opening Day draw a close with a dedicated Opening Ceremony that included official addresses from Amb. Jürg Lauber, Permanent Representative of Switzerland to the United Nations and other International Organizations in Geneva and Tatiana Valovaya, Director-General of the United Nations at Geneva via video message. The session continued with a conversation with Volker Türk, the United Nations High Commissioner for Human Rights, for his first public intervention since he took up his official functions on 17 October 2022. The ceremony ended with a panel discussion between Margot Wallström, Chair of the Environment of Peace initiative, former Swedish Minister for Foreign Affairs and European Commissioner for the Environment and UN Special Representative on Sexual Violence in Conflict, Hina Jilani, Member of the Elders, Lawyer and Civil Society Activist, Leading Activist in Pakistan's women's movement and international champion of human rights (online) and Achim Wennmann, Director of Strategic Partnerships at the Geneva Graduate Institute. The Opening Ceremony was attended by <u>167 participants</u>.

# 3.4 Briefings, Meetings and ad-hoc Events

The Platform continues to be a proactive convener on peacebuilding-related issues. Over the years, these activities have included lunch-time seminars, briefings for diplomats, consultations, informal meetings or workshops, retreats, or public conferences.

The Platform and its growing expertise in facilitation is an essential ingredient in the hybrid era. Online and hybrid exchanges must be carefully designed and wellfacilitated if they are meant to have an impact. These convenings can range from specific topics in peace (e.g. new trends in peace mediation or environmental peacebuilding) to the regional (Beijing-Geneva Digital Briefings on Sustaining Peace and Preventive Diplomacy). Although meetings in 2022 continued to be held both online and in-person to accommodate the Platform's ever-growing and changing audience needs, there has been an increased demand for in-person events, briefings and consultations.

In 2022, the War in Ukraine prompted the organisation of a series of briefings held monthly in cooperation with the Geneva Graduate Institute.

The Platform also remains alert to service short-notice requests for events or informal exchanges on critical peacebuilding issues as they emerge. The Platform is well recognized by senior peacebuilding actors visiting Geneva to reduce transaction costs when reaching out to the Geneva-based peacebuilding community.

# Beijing-Geneva Digital Briefings on Sustaining Peace and Preventive Diplomacy

The Institute of Asian Studies (IAS) of the China Foreign Affairs University (CFAU) and the GPP continued to collaborate on the Beijing-Geneva Digital Briefings on Sustaining Peace and Preventive Diplomacy.

The briefing series showcases exchanges between senior experts on innovative research and policy-making in the areas of sustaining peace and preventive diplomacy in view of finding solutions and fostering collaboration on common concerns. The briefing series builds on the rationale that the world is facing new strategic landscapes that require innovation about how different actors go about preventing violent conflict and sustaining peace. Mega-trends such as COVID-19, climate change, rapid urbanization, or geo-political change are accentuating existing stresses on countries and societies, and therefore emphasize the importance to rethink the toolbox available to de-escalate conflict and build trust in times of heightened turbulence and division. By convening briefings on a monthly basis, the Beijing- Geneva Digital Briefings aim to identify potential areas for a new research agenda in the fields of sustaining peace and preventive diplomacy.

#### Informal Communications Community

Since fall 2019, the Geneva Peacebuilding Platform has regularly convened a small, informal network of communications managers for various peacebuilding, security, and humanitarian organizations in Geneva. The goal of these meetings was to build bridges between communicators who are often the sole communications representatives within their teams, and to build capacity for communications towards Geneva Peace Week.

Following the transition year of 2022, the Communications Community Lunches were re-introduced over the summer in July 2022, reaching out to the Community to see when best to pick-up these moments of informal networking and skills sharing. The first one took place on 06 September 2022 to introduce the greater group to the Platform's new Communications & Outreach Coordinator, Yasmeen Chaudhry.

Due to the upcoming Geneva Peace Week, the Communications Community Lunches were replaced in favor of one one one meetings with each Head of Communications and/or responsible for the communications for Geneva Peace Week 2022 stakeholders in order to build rapport and create foundational synergies.

Following the conclusion of Geneva Peace Week 2022, the Communications Community Lunches resumed on: 22 November, 06 December, 17 January 2023, and 31st January 2023.



# **4. COMMUNITY MANAGEMENT**

Community management can be understood as the process of organizing a network of professionals around a common cause or topic. The Platform's work on community management sits on a solid foundation laid over multiple work plans. The Platform carried out activities for "network strengthening" from 2012-2014 and 2015-2017, and grew into managing Technical Working Groups (TWGs) on urban safety and peacebuilding, as well as business and peace in 2018 and 2019. In 2019, a Scoping Study on Geneva Peace Week recommended the enhancement of GPW's impact through the curation of topics and communities that are engaged in conversations throughout the year. The Platform's work on "community management" began in earnest in January 2020, mandated for the first time in the 2020-2021 work plan.

After an intensive year of community management on four tracks in 2021 and varying levels of success across them, the work plan proposal for 2022-2023 previewed yet another model shift for the work stream. The document proposed an investment of energy into the most robust tracks for 2022: Environment, climate, conflict, and peace (ECCP) and the Peace Forum Network.

#### Deliver the advancements of the Geneva Dialogue on Environment, Climate, Conflict, and Peace and manage its evolution

The Geneva Dialogue on Environment, Climate, Conflict, and Peace was the primary community management initiative emerging from the 2020-2021 Platform period. It continues today as an expansive project which aims to foster inter-institutional collaboration and dialogue, promote shared learning and innovation, and mainstream these topics across the board between the environment, climate, conservation, conflict, security, and peace sectors.

The Geneva Dialogue launched in March 2020 with various threads of activity. The community has grown and evolved over time. Principles activities are listed below with their chief outcomes.

#### Briefings and convenings


By the end of 2022, 58 briefings and convenings had been held, welcoming 25 speakers to address the community in private briefings. Each convening had an average of fifteen attendees. Participants have also collaborated at ten public, multi-day conferences over the past three years. #### A White Paper on the Future of Environmental Peacebuilding

In 2020, the Platform proposed a collective process with the community of practice to develop a White Paper on the Future of Environmental Peacebuilding. The White

Paper officially launched on 1 February 2022 online at the Second International Conference on Environmental Peacebuilding. 154 authors contributed to the compendium, 153 individuals provided feedback through a month-long consultation process, 9 illustrators and 2 designers worked with 1 art director to bring artistic life to the project, 9 individuals contributed to the Steering Committee governing the project, 3 editors wrote and edited the white paper and compendium, 2 consultants and communicators supported the dissemination of the project, and 1 facilitator organized the moving parts. # Dissemination of the White Paper and its use as a vehicle for shared policy influencing

In 2022, these efforts were then consolidated in an effort to deliver community-led and community-wide policy messages to major international environmental policy fora, including Stockholm+50 and COP27. The collaboration resulted directly in policy language adopted into Stockholm+50 outcome documents. This phase also offered the Geneva Peacebuilding Platform and the wider community of practice the opportunity to explore community-driven policy work, an effort to break down silos while achieving policy goals. The goal was not only to translate the concrete recommendations from the paper into the policy space, but also to translate the participatory process model of idea development into the policy space.

#### Preliminary outcomes:

Across these threads of activity, a number of outcomes can be observed. First, the subject has been successfully mainstreamed in Geneva. An increase of Geneva institutions allocating funding for staff time to work on the intersection of environment, climate, conflict, and peace has been observed. This increase in staff time translates to research, publications, advocacy, and more, all of which have transferred impact in the communities and countries where the institutions work. Second, the Dialogue has led to a number of positive connections between institutions and individuals. For example, community practitioners working in Somalia connected with professionals at the United Nations Environment Programme, which has led to the rooting of a pilot UNEP project in Somalia. There are scores of additional anecdotal connection stories.

Finally, the community of practice broke down silos and collaborated on policy messages for key international policy fora. The Platform and its Dialogue were invited to deliver a session on the relationship between climate change and peace at COP26 through Chatham House's Climate Security Pavilion. The community embarked upon a collective policy influencing exercise for Stockholm+50; as a result, for the first time, peace and security were referenced multiple times throughout the outcome documents of the conference, representing a marked difference and turning point in the global discussion on sustainable development. A similar collaborative effort was elaborated and executed at COP27, resulting in the host country of COP28 contacting the community of practice directly and requesting policy development inputs into the development of COP28.

Community management initiatives may not continue indefinitely or stay within the Platform itself. An evaluation study is currently underway to elaborate key outcomes of the project and propose potential pathways forward.

# $4.2\,$ Identify, incubate and accompany thematic processes, linking to GPW

Before 2021, an assumption was made that the Platform would solely provide some lighter administrative support to multiple thematic tracks at the same time. One or two staff might be able to accompany many different tracks.

The pilot phase in 2020-2021 demonstrated that repeated effort and significant time investment yield significantly more positive results and a more cohesive community. In effect, one staff member can accompany one thematic track, with a bit of time left for incubation and ad hoc convening. This staff member can also accompany the track to Geneva Peace Week.

This one-staff-per-track model reflects the human resource intensive nature of networking efforts, especially with respect to the networking with different actors in Geneva, participant development, and consolidation of the contact database. In some aspects, core partners of the Platform can lend support and leadership for thematic tracks, including recruiting track participants, scouting for expert briefers, and contributing to knowledge projects. In other aspects, however, it may be difficult to call upon partners to support, such as administrative and database management, community communications, and project coordination.

# 4.3 Institutionalize a Community Management strategy, integrating community organizing best practices and communications

In 2022, a formal and comprehensive community management strategy was elaborated by the Community Management Lead. The strategy is currently under review with Platform leadership.

The strategy also includes multiple annex documents, including previous community management concept notes and key documents relating to previous and current thematic topics.

## 4.4 Manage and facilitate the Peace Forum Network

Since the summer of 2020, the Platform has convened an informal Peace Forum Network of more than twenty participants who work for various peace for a around the world. The Network is meant to provide a space for exchange and innovation across the peacebuilding field.

The network meets once per quarter. In 2022, the network met online on 29 June, 15 September, and 5 December 2022, each dialogue a ninety-minute interactive meeting designed to maximize interaction and information sharing. In lieu of a meeting in Q1, the Peace Forum Network hosted a public event at the Alliance for Peacebuilding's PeaceCon, "The Role of Peace Fora in Peacebuilding." The event gathered different peace forum convenors and audience members to discuss opportunities and challenges for peace fora in supporting ongoing peace efforts around the world.

The network continues to meet in 2023, starting off the year with a long-form online retreat that took place on 21 March 2023. This retreat provided a space for participants to explore and evaluate global challenges and articulate concrete differentiation between their unique fora identities and approaches.



# **5. GENEVA PEACE WEEK**

Geneva Peace Week 2022 (GPW22) took place from 31 October to 4 November 2022 at the Maison de la Paix Campus, in facilities of the Geneva Graduate Institute, the Geneva Center for Security Policy and the Geneva Graduate Institute's Conference Center. After two editions that were held almost fully online due to the global pandemic (in 2021, the Opening and Closing ceremonies were held in person), considerable efforts have been made to offer as many traditional in person events as possible while keeping some sessions online to retain the reach and expansion that was successfully achieved in prior editions.

The programme was developed through an inductive process beginning with the review of 92 session applications received in June 2022, based on the overarching theme **"Peace is possible"**. As with previous years, these applications offered an opportunity to identify innovative practice and key thought leadership in peacebuilding across the world. The very high quality of the applications led to the elaboration of a full programme developed along four thematic tracks:

- 1. Rights, inequalities and peace: Navigating tensions, finding opportunities
- 2. Moving beyond securitization: Risk management and new horizons for peacebuiling
- 3. Digital peace: The power and limits of innovation in peacebuilding
- 4. Cultivating cooperation: Environmental challenges and opportunities for peace in a new age of insecurity

# 5. GPW22 Key figures



## 5.2 Digital Series

The 2022 Digital Series featured 21 contributions, in which organizers developed their peacebuilding expertise, research, and stories into short, educational and digital formats (videos, podcasts, and other media). The Digital Series format was adapted for the GPW22 edition to bring focus on information-sharing that is concise, but in-depth, with the goal of educating online audiences on peacebuilding topics related to GPW22. The Digital Series contributions are broadcasted on the GPW website and major streaming platforms (including YouTube and Spotify etc.).

The Series offers an opportunity for contributions to continue beyond Geneva Peace Week, across geographical, cultural and temporal borders.

2 online sessions called "Selected Digital Series" were organized during GPW22, designed to give GPW attendees the opportunity to meet and interact with organizations that contributed to the series, with an average of 30 attendees per session.

## 5.3 Side events

#### Kofi Annan Geneva Peace Address

The Kofi Annan Foundation, the Geneva Graduate Institute and the Geneva Peacebuilding Platform organized the second edition of the Kofi Annan Geneva Peace Address, a high-level lecture on peace held every year as part of Geneva Peace Week. This Address was delivered by Elena Zhemkova, Co-Founder and Executive Director of the Russian human rights organization Memorial, recently awarded the Nobel Peace Prize for 2022. The event was the most well attended of the whole GPW22 with more than 300 attendees.

#### Geneva Peace Week Radio Corner

On Opening Day, Fondation Hirondelle, Interpeace, and RTS/GenèveVision cohosted a radio corner on the premises of the Geneva Graduate Institute. Listen to the recordings from the official Geneva Peace Week Radio Corner <u>here</u>.

#### Geneva Peace Cast

The Geneva Peace Cast is a collaboration between Interpeace, Fondation Hirondelle, and the Geneva Peacebuilding Platform, on the production of a podcast series during the GPW22 to amplify the discussions happening throughout Geneva Peace Week. A total of 7 episodes were produced for this second edition of the Geneva Peace Cast and are available on Spotify. Each episode covers a topic discussed during GPW22 and features GPW22 guest speakers, including peacebuilders, researchers, diplomats, journalists, from all continents.

# 6. OUTLOOK

The year 2022 has been an important transition year for the Geneva Peacebuilding Platform. With the new Program for 2022, the Platform, with its new Executive Director, Dr. Annyssa Bellal, strived to implement a strategic direction and key activities geared along the following three axes:

1. Vision: Through its Partners Membership and International Advisory Board constituency, including key UN agencies and programmes, the GPP can provide strategic advice and foresight on core peacebuilding issues relevant to the broad international agenda.

2. Sharing knowledge: As an international knowledge hub on peacebuilding, the GPP identifies briefers and share knowledge, including by way of policy applicable briefings on critical peace and security issues.

3. Testing grounds: As a convening actor on Peacebuilding issues in Geneva, the GPP provides a safe space of discussion and closed-door peer-to-peer meetings for review of policy briefs being developed by relevant stakeholders.
